MINUTES N. 2

On the 11th of September, 2024, from 8:15 am to 1:00 pm, in Sala Riunioni at the ground floor of Torre Building, the Selection Committee of the “Concorso” for admission onto the PhD programme in "Management, Finance and Accounting - XL cycle in agreement" (hereinafter referred to as "the programme") appointed by the Rectoral Decree n. 1215 of July 12th, 2024, held its second meeting of the “Concorso” to which it applied the legislative provisions on public “Concorsi”.

The Committee declared the absence of incompatibility, according to the article 51 of the Civil Procedure Code and article 7 of Presidential Decree 62/2013, of among the members and between them and the applicants.

The Committee acknowledged all the provisions contained in the Ministerial Decree of 24 April 2024 no.630 attributing NRRP financing (Mission 4, component 2, investment 3.3 – “Introduction of innovative doctoral programs that meet the innovation needs of companies and promote companies’ recruitment of researchers”) for new scholarships for innovative PhD courses that meet the innovation needs of companies for 3-year PhD scholarships within the XL cycle.

The Selection Committee identified the criteria for the evaluation of the oral test:

- ability to analyse and to discuss economic and social phenomena with a scientific approach;
- motivation towards scientific activities;

- solving test of general knowledge and logical reasoning

All applicants were identified by reference to their identity document and submitted to the interview.

In accordance with the announcement, the interviews were carried out according to the evaluation criteria until 1.00 pm.

The committee declared that the selection procedure respected, where relevant, the following transversal principles as set out in EU Regulation 2021/241: a) the principle of gender equality; b) the principle of the promotion and valorisation of young people; c) the principle of overcoming territorial disparities.

After extensive and in-depth discussion, the Selection Committee attributed to the applicants the following ratings for Profile c), which were combined with those for Profile a) and Profile b), summing the relative scores.

The Selection Committee then proceeded to the formulation of the following judgments:

Attached is the final graded list of scores with the list of admitted applicants.




